1. **The Nuts and Bolts of Federal Firearms Law**

This presentation will cover the most common legal issues arising during both the guilt-innocence phase and the sentencing phase of federal firearms cases, with particular emphasis on prosecutions under 18 U.S.C. §922(g) (1) (the felon in possession statute) and the corresponding sentencing guideline, USSC §2K2.1. Common trial defenses and sentencing enhancements (including the statutory enhancement for armed career criminals) will be reviewed.

2. **The Adam Walsh Act**

The Adam Walsh Child Protection and Safety Act of 2006 was enacted on July 27, 2006. In addition to establishing a national sex offender registry law, the Act made significant changes to sexual abuse, exploitation, and transportation crimes. The Act created new substantive crimes, expanded federal jurisdiction over existing crimes, and increased statutory minimum and/or maximum sentences. This session will provide an overview of the Act and discuss bail, discovery and prophylactic measures.

3. **Culture Clash: Cultural Issues in Criminal Defense**

This presentation will explore how cultural factors can have a significant impact on defending a criminal case. This topic is of great importance given the high number of defendants from other cultures in the criminal justice system. United States on the courts' sentencing process.
