RESEARCH AND WRITING SPECIALIST – CAPITAL HABEAS UNIT
Office of the Federal Public Defender
Western District of Texas (Austin)

THE FEDERAL PUBLIC DEFENDER for the Western District of Texas is now accepting applications for the position of research and writing specialist for its newly forming Capital Habeas Unit in Austin, Texas. The Capital Habeas Unit (CHU) is responsible for representing death-sentenced prisoners in federal habeas corpus proceedings in the United States District Courts in Texas, the United States Court of Appeals for the Fifth Circuit, and the United States Supreme Court. The CHU will represent indigent, death-sentenced prisoners in all four federal districts in Texas.

Requirements. The research and writing specialist position is an attorney position. Applicants must be: (1) a graduate of an accredited law school; and (2) admitted to practice in good standing before the highest court of a state. A minimum of three years of specialized experience is preferred. Appointment is subject to a satisfactory background investigation, including but not limited to an FBI name and fingerprint check.

Duties. The primary duties of a research and writing specialist include advanced legal research and writing services and litigation assistance to staff attorneys working in the CHU, who are representing clients in federal capital habeas corpus proceedings. A research and writing specialist is required to stay up to date on the latest developments in habeas corpus and criminal procedure; draft petitions and appellate briefs in the federal courts; analyze and research records; extensive client contact and correspondence, and field work gathering records and conducting investigation. The research and writing specialist is not an assistant federal public defender and does not ordinarily sign pleadings or make court appearances. The position requires occasional travel.

Selection Criteria. The successful applicant for research and writing specialist will have an established capacity or clearly demonstrated aptitude for excellence in criminal defense practice, a commitment to the representation of indigent accused persons, and a reputation for integrity. The successful applicant will have strong legal research and word processing skills, will be able to analyze legal issues from complex records, and will write clearly and concisely. Applicants also must possess the ability to communicate effectively with clients, witnesses, colleagues, and court and agency personnel; be able to work effectively in a team-based environment; possess strong oral and interpersonal skills; and be able to work independently and set priorities to meet critical deadlines. Appellate writing experience or experience in handling federal criminal cases is preferred.

Salary and Benefits. The starting salary for a research and writing specialist falls within a range of \$50,158 (JSP-9, Step 1) to \$120,228 (JSP-15, Step 1). The salary of the successful applicant will commensurate with the person's qualifications and experience. The position is in the excepted service and does not carry the tenure rights of the competitive Civil Service. The position offers federal government employment benefits, including participation in health and life insurance, retirement, and the Thrift Savings Plan. Salary is payable only by Electronic Funds Transfer (direct deposit).

How to Apply. Qualified persons may apply by forwarding a letter of interest (mentioning announcement number 17-14), résumé, and representative writing sample.
