Position: Assistant Federal Public Defender – Capital Habeas Unit

Location: Dallas Division

The Federal Public Defender for the Northern District of Texas is accepting applications for a full-time Assistant Federal Public Defender in the Capital Habeas Unit (CHU). The CHU represents indigent defendants on death row in Texas. Through an interdisciplinary team approach, we provide our clients with the highest level of legal representation with respect to their convictions and death sentences. CHU attorneys regularly litigate in federal district court, the Fifth Circuit Court of Appeals, and the United States Supreme Court.

It is critical to our clients' representation that the office be comprised of individuals from diverse cultures and backgrounds. The CHU seeks an applicant with at least one year of post-graduation capital litigation experience at trial, direct appeal, or post-conviction. Applicants with some capital litigation experience who may fall slightly below this one-year requirement at the time of their application are still encouraged to apply. However, some practicing capital litigation experience is mandatory.



The successful applicant must be a talented legal writer, possess excellent research skills, be team oriented, and be committed to indigent criminal defense. Duties include researching and writing motions, habeas petitions, and appellate briefs; working with investigators and mitigation specialists to develop investigation plans; and appearing in court for evidentiary hearings and oral argument. Skilled collaboration, strategic litigation, and compassionate representation are among the values we aim to foster in our CHU. Because no single person can do this work alone, you will work with experienced lawyers, mitigation specialists, and paralegals in the CHU. The ability to work well on a team is mandatory.



Fluency in Spanish is very desirable.

Applicants must be a graduate of an accredited law school, and be a member in good standing of the highest court in the state where licensed, but a Texas bar license is preferred. Applicants must be a U.S. Citizen or a lawful permanent resident who is eligible to work in the U.S., and is either currently seeking U.S. Citizenship or intends to become a U.S. Citizen when eligible.

Salary and Benefits: The position is full-time with federal benefits and salary commensurate with experience and qualifications. The position is excepted service and does not carry the tenure rights of the competitive Civil Service. Benefits include health and life insurance, retirement, and the Thrift Savings Plan. Salary is payable only by direct deposit. A final offer of employment is subject to a background check.

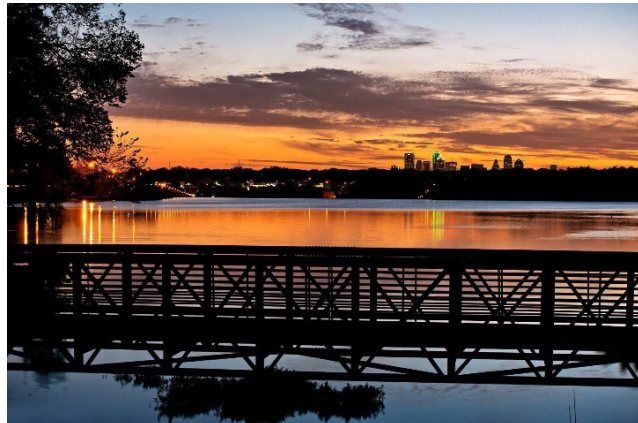
