We are looking for someone who is committed to equal justice and willing to fight vigorously for those accused of crimes.

### **Trial Attorney Essential Duties & Responsibilities**

The trial attorney will work as a part of a legal team, including investigators, paralegals, social workers and support staff to represent clients accused of federal crimes in all phases of litigation, from arrest through trial and sentencing. Caseloads may be comprised of, but are not limited to bank robbery, drug trafficking, firearm possession, fraud, immigration-related offenses, and internet-related crimes including child pornography.
