INTERPRETER FEES ALLOWABLE UNDER THE CRIMINAL JUSTICE ACT

The judges of this Court, having considered the matter of the currently allowable interpreter fees under the Criminal Justice Act, find the same will be increased from \$55 per hour to \$60 per hour for language skilled interpreters, to \$70 per hour for professionally qualified interpreters, and to \$80 per hour for federally certified interpreters. Interpreters will not be reimbursed for travel time between San Diego, CA and El Centro, CA or San Luis, AZ, without prior approval by the CJA Supervising Attorney, upon a showing of good cause. To the extent such travel is approved, the travel rate will be no more than \$50 per hour. Interpreters will be allowed to bill one hour for in-person meetings that are one hour or less.

The rates herein will be effective February 1, 2023.
