**ORDER APPOINTING CLERK OF COURT AS  
AGENT FOR ACCEPTANCE OF SERVICE**

The Judges of this Court hereby authorize and appoint the Clerk of Court for the United States District Court for the District of Connecticut, and all deputies thereof, to accept service of process, pursuant to Federal Rules of Civil Procedure 4(i)(3) and 4(e)(2)(C), on behalf of the District Judges, Magistrate Judges, staff of the District Court, and officers and staff of the United States Probation and Pretrial Services for the District of Connecticut when any such individual is sued in an individual capacity for an act or omission occurring in connection with duties performed on the United States' behalf, and to accept a copy of the summons and the complaint sent by registered or certified mail pursuant to Federal Rule of Civil Procedure 4(i)(2) when any such individual is sued only in an official capacity.

Individual judges and staff members may opt out of this appointment by written letter to the Clerk of Court.

Nothing in this Standing Order affects a litigant's obligation to also serve the United States pursuant to Federal Rule of Civil Procedure 4(i)(1) when suing an individual in an official capacity or in an individual capacity for an act or omission occurring in connection with duties performed on the United States' behalf. See Fed. R. Civ. P. 4(i)(2), (3).

This appointment shall remain in effect until such time as it may be terminated or replaced by a subsequent appointment.
