SUPERSEDING ADMINISTRATIVE ORDER

With the concurrence of the majority of Article III Judges in the District, this Administrative Order is entered for the Court; it supersedes Administrative Order 19-MC-00004-33, *In the Matter of: Delegation of Approval Authority for Certain CJA Vouchers* and Administrative Order Misc. No. 03-81, *In the Matter of: Delegation of Approval Authority for Criminal Justice Act Claims Submitted for Payment in the Amount of \$1,000.00 or Less*.

Authority under the Criminal Justice Act to approve vouchers claiming payment and reimbursement is delegated to the CJA Resource Counsel, who will authorize payment for the following after reviewing for reasonableness, technical correctness, and mathematical accuracy:

1. Vouchers of \$5,000 or less for attorney services in all felony, misdemeanor, non-capital habeas, and other criminal proceedings (CJA-20), except for vouchers which are submitted as interim payments; and
2. Vouchers of \$2,700 or less for all service providers in all felony, misdemeanor, non-capital habeas, and other criminal proceedings (CJA-21), except for vouchers which are submitted as interim payments.


Requests for approval for attorneys seeking compensation in excess of case compensation maximums (CJA-26), requests for service providers (AUTH), requests for approval for overnight

or out-of-district travel (Travel AUTH), requests for creation of transcripts (AUTH-24) and vouchers for payment of transcripts (CJA-24) will continue to be submitted to the presiding judicial officer for approval, regardless of amount.

IT IS SO ORDERED.
