About Us

The Federal Defender Program, Inc. (FDP) is a private, nonprofit law firm devoted to uplifting our clients and their causes through excellence in federal criminal defense. The Trial Unit represents persons charged with federal criminal offenses in the Northern District of Georgia. The Capital Habeas Unit represents death-sentenced clients in all stages of their federal court litigation. The Northern District of Georgia encompasses the Atlanta, Gainesville, Newnan, and Rome Divisions, each with its own courthouse. By far, the majority of Northern District of Georgia prosecutions take place in the Atlanta Division, where our office is also located.

The most common cases we handle involve drug offenses, firearms offenses, fraud and financial crimes, and immigration offenses, though our work spans the full range of federal criminal litigation—from investigation through trial, sentencing, appeal, and post-conviction proceedings. Our representation also includes some capital defense work in the Trial Unit and post-conviction capital work in the Capital Habeas Unit.

FDP is a nonprofit Georgia corporation fully funded by the Administrative Office of the United States Courts. We are not a government agency, and our employees are not government employees.

About the Role

The CHU Mitigation Specialist / Investigator plays an integral role in the investigation and presentation of both guilt/innocence and penalty-phase issues at all stages of habeas corpus proceedings, as well as stay litigation and executive clemency.

Core duties include:

- Building relationships with clients and their families;
- Assisting attorneys in investigating and developing clients' life history evidence;
- Reviewing, analyzing, and organizing voluminous case files and records;
- Identifying and initiating new areas of investigation;
- Gathering and assessing documentary and other evidence;
- Locating and interviewing witnesses;
- Drafting memoranda, declarations, chronologies, and social history reports;
- Working with experts;
- Serving subpoenas; and
- Assisting with hearings.

Work Environment

- This is an in-person position. After a probationary period of employment, team members may be permitted to work remotely one day per week with supervisory approval.
- The Mitigation Specialist / Investigator will work collaboratively with paralegals and under the supervision of one or more attorneys.
- The position requires extensive overnight travel and work outside of business hours, including weekends and holidays.
- This position occasionally requires lifting or moving materials weighing up to 25 pounds.

Qualifications

We are seeking a mitigation specialist who brings skill, curiosity, compassion, and professionalism to this deeply human work.

- Bachelor's degree from an accredited college or university.
- Experience relevant to the investigation and development of mitigating evidence, preferably in capital trial or post-conviction cases.
- A desire and capacity to work collaboratively in a multidisciplinary team environment.
- A strong commitment to providing holistic representational support and to working with and on behalf of people from diverse backgrounds.
- The ability to build relationships and develop rapport with clients and their families, and to gather and analyze anecdotal and documentary evidence related to a client's life history.
- The ability to work independently and proactively, including recognizing and assessing mental health symptomatology and determining the most effective mitigation investigation approach for each case.
- Strong organizational skills to gather, maintain, and manage documents and information for assigned cases, and the ability to interpret, analyze, and integrate records and legal documents.
- The ability to communicate effectively, both orally and in writing, with counsel and experts, and to assist in identifying and selecting appropriate experts.
- Attention to accuracy and detail.
- Computer proficiency in Microsoft Office programs, including Word and Excel, and in Adobe Acrobat.
- The ability to maintain confidences, protect legal privileges, and demonstrate personal and professional integrity.
- The ability to work under time pressure and appropriately prioritize responsibilities.
- This position requires travel to courts, detention facilities, and other case-related locations, as well as occasional overnight travel. Applicants must have a valid driver's license, reliable personal transportation, and current automobile insurance. Mileage is reimbursed at the federal mileage reimbursement rate.

Applicants must be authorized to work in the United States at the time of hire.

Salary and Benefits

The starting annual salary for this position falls within a range under the Judicial Salary Plan (JSP) from Grade 11 at \$76,671 to Grade 14 at \$167,876. The salary of the successful applicant will be commensurate with the person's qualifications and years of experience.

Benefits: Paid vacation, paid sick time, paid holidays, health insurance, life insurance, and participation in our 401(k) plan.
