This session will look at investigating and challenging forensic firearms comparison as a backdrop to informing Daubert litigation. The use by the government of forensic pattern impression evidence has become ubiquitous in criminal cases with experts making claims that often overstate what existing scientific research supports. During this session, we will discuss how to investigate and prepare to litigate the admissibility of pattern impression evidence and how to challenge it in trial using firearms comparison as an example.
